On November 10, 2025, the Literary Club of NHCE hosted "*Pearson Specter Litt*," a Suits-themed courtroom debate designed to merge intellect, strategy, and performance. The Chanakya Seminar Hall was transformed into a professional courtroom setting where 16 duos, representing 32 participants, stepped into the shoes of lawyers to argue complex and thought-provoking cases before a live audience.

The event aimed to cultivate analytical thinking, persuasive communication, and quick reasoning under pressure. Participants were assigned cases drawn from *The Global Casebook*, each addressing themes from politics, ethics, law, and contemporary issues. In total, 25 unique cases were featured, including **Was 9/11 an Inside Job, CSK Fixing Ban Appeal, The Moon Landing Real or Staged, The Gaza Conflict Allegations Before the ICC, The Harshad Mehta Securities Scam, The Death of Princess Diana, Freedom of Expression in Comedy, The O.J. Simpson Trial, The JFK Assassination, The Chinnaswamy Stadium Stampede, The Silverline Rail Corridor Dispute**, and several others that balanced real incidents with fictional narratives.

Each duo represented opposing sides and argued their cases with remarkable composure and creativity. Participants demonstrated a profound understanding of their cases, substantiating claims with evidence and sound legal reasoning while maintaining courtroom decorum. The briefing began at 11:30 AM, followed by the first round of proceedings at noon. Participants arrived in formal Suits and inspired attire, which added authenticity to the courtroom atmosphere and aligned perfectly with the event's theme.

Members of the Literary Club acted as the jury, carefully evaluating performances based on the quality of arguments, coherence, delivery, and teamwork. Two senior members of the club presided as judges, ensuring a fair trial and guiding the participants through each session. The combination of structured debate, legal reasoning, and theatrical presentation created a truly immersive experience.

After multiple rounds of arguments and counterarguments, the top duos advanced to the final round, where the stakes were higher and the energy was electric. The finalists delivered compelling arguments that combined confidence, logic, and wit, earning thunderous applause from the spectators. The winning team was conferred the title of *Best Lawyers of Pearson Specter Litt* for their exceptional reasoning and poise.

*Pearson Specter Litt* was a resounding success that showcased the Literary Club's creativity, precision, and dedication to fostering intellectual engagement. The event not only entertained but also encouraged participants to think critically, argue rationally, and perform confidently.
